Geoffery G. Maclay: Land Trust Visionary by Linda Mutschler

On April 17, 2021, CLCF--and the land trust movement in Wisconsin--lost both a remarkable visionary and a tireless advocate for land conservation with the passing of Geoffrey G. Maclay.

Inspired by land conservation efforts on Nantucket, Geoff established CLCF in 1974. At the time, land trusts were a novel concept, and CLCF was one of the first land trusts in Wisconsin. With the other founders of CLCF, Geoff worked to preserve the scenic and rural character of the Cedar Lakes region that he'd come to love since arriving at Big Cedar Lake in the late 1940s.

Change starts with individual action, and Geoff helped to launch CLCF's bold mission by donating 44 acres of land in the Little Cedar Kettle. That parcel includes a long stretch of Cedar Creek from Little Cedar Lake all the way to HWY NN. Geoff followed up that initial donation with two more gifts of land, including an additional 24 acres in the Little Cedar Kettle as well another 15 acres along Cedar Creek, stretching all the way from the dam at Big Cedar Lake to County HWY NN.

Geoff was a founding member of Gathering Waters, Wisconsin's alliance for land trusts, and in 2006 he was awarded its Harold "Bud" Jordahl Lifetime Achievement Award. Over the years, Geoff worked closely with the Wisconsin Department of Natural Resources, the National Park Service, and the Ice Age Trail Alliance to protect the unique Kettle Moraine topography in Washington County. Geoff also served as one of the original architects for Wisconsin's Knowles-Nelson Stewardship Program.

CLCF and those who enjoy the land that Geoff has helped to protect are forever grateful for his leadership and dedication. Over the years, Geoff and CLCF have protected nearly 2,550 acres—or 21% of the land in CLCF's mission area. Imagine what this area would look like without that land protection or what the water quality would be.

Geoff's vision was to sustain the abundant natural beauty, clean water and biodiversity of the Cedar Lakes region for generations to come. CLCF continues that vision to this day.

As we often say at CLCF, "There are a limited number of ways to make an impact that lasts beyond a lifetime. Protecting land is one of those ways."

Geoff Maclay truly embodied the meaning of these words.

He was a champion of conservation, a risk-taker, an innovator, and a pioneer. There is no question that he made an impact that will last beyond his lifetime. His legacy will be enjoyed by and will benefit generations to come.

CLCF will continue to further Geoff's life work conserving the natural environment of the Cedar Lakes region, but we will greatly miss his wisdom, his wit and his determination.

As spring arrived, Stew Crew turned its attention to tree tube maintenance. It was exciting to see the trees continue to grow across CLCF's properties. At Timmer's South, volunteers removed most of the remaining tree tubes as the trees have done so well that they are no longer needed. Many of the trees that Stew Crew volunteers planted at the West Property in May 2020 survived the winter and were sprouting up in the spring.

With spring came the return of Garlic Mustard Pulls. A hearty crew hiked about 15 minutes into CLCF's Girl Scout Property on a Saturday morning, pulled Garlic Mustard for three hours and then realized they had to carry out all the bags. It was a serious work out!

There was Thistle cutting in the Timmer's pollinator prairie and at the Joan M. Pick Nature Preserve, where the thistle was almost as tall as the volunteers. Several brave souls also went into the Mueller prairie to work on eradicating Wild Parsnip.

Starting in the fall, CLCF has again partnered with Project Wingspan, where a number of Stew Crew volunteers gather seeds from the Joan M. Pick Nature

Growing Beetles to Tackle Purple Loosestrife

This year marked the first year that CLCF grew Cella Beetles at the Joan M. Pick Nature Preserve to help with Purple Loosestrife management. Over the last fifteen years, Lee and Mary Krueger had grown the beetles on their property for CLCF and others. We are incredibly thankful to both Lee and Mary for their dedication to CLCF and the land of the Cedar Lakes region.

Invasive species are a major challenge for maintaining wildlife habitat and biodiversity on CLCF's protected lands. One such species, Purple Loosestrife, is a wetland plant native to Europe, Africa, and Asia that was brought to the Great Lakes region in the mid-19th century through the nursery trade and in ship ballasts. Purple Loosestrife tends to occupy wetlands and shorelines, where it can produce upwards of 2 million seeds per plant per year. Left unchecked, Purple Loosestrife can convert some of Wisconsin's most biodiverse habitats into monocultures in a matter of years.

These Purple Loosestrife monocultures reduce or eliminate sensitive breeding habitat for birds, fish, and amphibians and alter local hydrology in ways that can make water unnavigable. All these factors make controlling Purple Loosestrife a land management priority for CLCF.

While herbicides are usually invaluable tools for controlling invasive plant species, using herbicide in aquatic habitats requires special chemical formulations to reduce negative impacts on aquatic life, and even these can still damage the reproductive systems of fish and amphibians. Instead, CLCF employs a strategy known as biocontrol to manage Purple Loosestrife. Biocontrol typically involves introducing a predator, parasite, or disease that already curbs the competitiveness of the invasive species in its native range. Historically, there are famous botched biocontrol experiments that had huge, unexpected consequences like the Cane Toad in Australia and the Asian Mongoose in Hawaii. Today, biocontrol agents are subjected to decades of research before being approved as management tools. In the case of Purple Loosestrife, CLCF employs a type of beetle known as Cella Beetles, which were one of the first biocontrol agents to be approved for use in the United States. Cella beetles are excellent biocontrol agents because they are obligate to

Purple Loosestrife, meaning that their entire lifecycle is fully dependent on Purple Loosestrife.

This year, CLCF released Cella beetles to Gilbert Lake and Paradise Valley Lake. In the case of Paradise Valley Lake, we are trying to stop a small population of Purple Loosestrife from gaining a foothold, and on Gilbert Lake we are chipping away at a large population that takes up over half of the lake's existing shoreline. Over time, the beetles will reduce the cover of Purple Loosestrife and allow native species to germinate from the existing seedbank in the soil. Amazingly, many native plant seeds can persist in wetland soils for decades in the absence of draining and plowing.

Diverse plant communities form the backbone of our ecosystems, and our lakeshores are no exception. If we want a future that includes pristine landscapes and bountiful wildlife, we need to do our part today to protect the smaller things that support the land and water we love.

Lehman Rosenheimer came to be known as the Merchant Prince of Washington County. He emigrated to the United States from Germany in 1842 with approximately \$200 in his pocket, eventually settling in Slinger (then called Schleisingerville). With the help of his family, he built one of the largest and most successful country stores in the state of Wisconsin, such that "the trade of nearly all the adjoining towns" centered on his store. His sons expanded into Kewaskum and purchased extensive properties on both the east and west sides of Big Cedar Lake.
